WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as a portion of Lot 139 on a Plat of ORCHARD ACRES, Part of Section II, recorded in the RMC Office for Greenville County in Plat Book QQ, at Page 6, and having, according to a more recent survey by Jones Engineering Service dated October 25, 1973, the following metes and bounds:

BEGINNING at an iron pin on the southern side of Northway Drive at the northeastern corner of Lot 139 and running thence, s 00-56 E, 171.9 feet to an iron pin; thence S 85-36 W, 102.8 feet to an iron pin in the rear lot line of Lot 139; thence along a new line through said Lot, N 04-06 E, 83.5 feet; thence continuing along a new line through said Lot, N 08-13 E, 96 feet to an iron pin on the southern side of Northway Drive; thence with said Drive, N 88-19 E, 80 feet to an iron pin, the point of beginning.
