WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of SEVENTY THOUSAND AND NO/100 ----- DOLLARS

(\$70,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 29 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

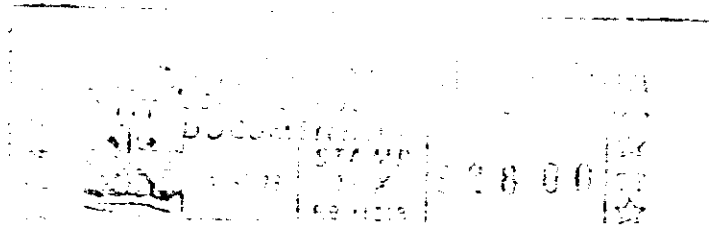
WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeastern side of Huntington Road, being shown and designated as Lot No. 65 on a plat of Huntington Woods, Sheet No. 3, made by Piedmont Engineers and Architects, dated May 4, 1968, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book WW, Page 25 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Huntington Road at the joint front corner of Lots Nos. 64 and 65 and running thence along the common line of said lots, S. 18-02 E., 386.79 feet to an iron pin; thence N. 64-50 E., 180 feet to an iron pin at the joint rear corner of Lots Nos. 65 and 66; thence along the common line of said lots, N. 6-00 W. 344.77 feet to an iron pin on Huntington Road; thence along the southeastern side of Huntington Road, S. 80-50 W., 105.2 feet to an iron pin; thence continuing along said side of Huntington Road, S. 76-15 W., 147.5 feet to an iron pin, the point of beginning.

The above property is the same property conveyed to Marta Tucker Stover by deed of Hugh B. Croxton and H. Caldwell Harper recorded November 3, 1975 in Deed Book 1026 at Page 695.
