WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of ----- SIXTY THOUSAND AND NO/100----- DOLLARS

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 226, Map Number Two, Section One, Sugar Creek, a plat of which is recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 4R, Page 85, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northerly side of Oak Ridge Court at the joint front corner of Lots Nos. 226 and 227, and running thence with the joint line of said lots, N 02-46-21 W 170.01 feet to an iron pin in the joint rear corner of Lots Nos. 226, 227, 230, and 231; thence with the joint rear line of Lots Nos. 226 and 231, N 56-26-55 E 85.57 feet to an iron pin at the joint rear corner of said lots on the westerly side of Tract B; thence with the westerly side of Tract B, S 23-28-05 E 190 feet to an iron pin; thence S 56-00-22 W 116 feet to an iron pin in the northerly side of Oak Ridge Court; thence with the northerly side of Oak Ridge Court, the chord of which is N 62-38-50 W 47.94 feet to the point of beginning.
