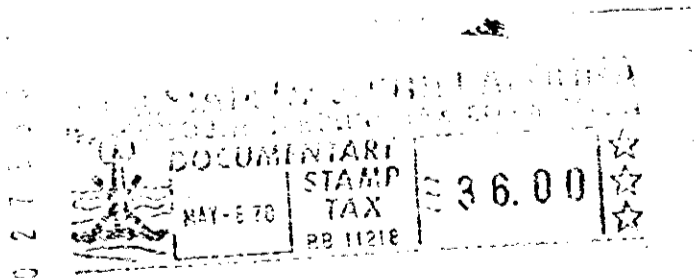
All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, City of Greenville, situate on the southwest side of Buncombe Street, having the following metes and bounds:

BEGINNING at an iron pin on the southwest side of Buncombe Street, which pin is N. 32-11 W. 192.5 feet from the intersection of the rights of way of Buncombe Street and Butler Avenue and running thence with the wall of a building situate on the subject property, S. 52-30 W. 147.0 feet to the corner of said building; thence with another wall of said building, S. 38-47 E. 70 feet to an iron pin at the corner of said building; thence S. 52-17 W. 67 feet to an old iron pin; thence N. 32-30 W. 195.6 feet to an iron pin; thence N. 55-27 E. 206.3 feet to an iron pin on the southwest side of Buncombe Street; thence with the southwest side of Buncombe Street, S. 32-11 E. 114.5 feet to beginning corner.
