TO ALL WHOM THESE PRESENTS MAY CONCERN: BEN ROBERTSON AND JANE ROBERTSON

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty Two Thousand Six Hundred Fifty and NO/100 - - - - - DOLLARS

(\$ 32,650.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

ALL that certain piece, parcel, or lot of land situate, lying, and being in the State of South Carolina, County of Greenville, in Bates Township, near Travelers Rest, South Carolina which is all of Lot No. 39 and a portion of Lot No. 38 according to a plat of Brookgreen, recorded in the R.M.C. Office for Greenville County, in Plat Book MM, at Page 141, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin located on the southern side of Tigerville Road, joint front corners of Lots Nos. 17 and 39; thence N. 82-40 E. to an iron pin; thence along Tigerville Road N. 75-34 E., 29.9 feet to the intersection of Tigerville Road and Dell Circle, thence with curve of said intersection 48.3 feet (the chord of which being S. 67-52 E.) to an iron pin on Dell Circle; thence with Dell Circle, S. 31-18 E., 83.3 feet to an iron pin, joint corner Lot No. 39 and formerly Lot 38; thence with Dell Circle S. 17-42 E. 40 feet; thence S. 72-18 W., 180 feet; thence N. 17-42 W. 40 feet to an iron pin; thence N. 17-42 W. 130 feet to the beginning corner.
