Due and payable in five equal annual installments of \$1,990.00 each beginning May 19, 1979, with the balance due on or before five years from date

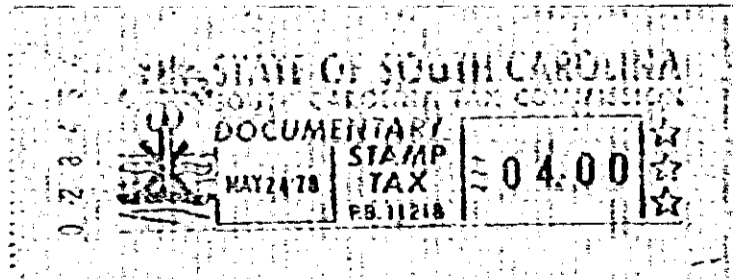
