TO ALL WHOM THESE PRESENTS MAY CONCERN: Richard Hoffman

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Associates Financial Services Co Inc (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Eighteen Thousand One Hundred Twenty and No/100 DOLLARS (\$ 18,120.00 ), with interest thereon from maturity at nine per centum per annum, said principal and interest to be repaid: in 120 equal monthly installments of \$151.00 each, the first of said installments being due and payable July 3, 1978, and a like installment due on the same day of each month thereafter until paid in full.

Amount advanced: \$9,014.22

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwestern side of Joe Lewis Avenue, being shown and designated as Lot Number 14 on plat of Arnold Place prepared by Dalton & Neves, Engineers, dated December 1944, as recorded in Plat Book O at Page 111 of the RMC Office for Greenville County. This is the same property conveyed to the Mortgagor by deed of Jeanne D. Threatt dated May 19, 1978 and recorded on even date herewith.

ALSO: ALL that certain piece, parcel or lot of land in the County of Greenville, State of South Carolina, known and designated as Lot Number 5 on plat of property of the Estate of Aaron Brockman, recorded in Plat Book A at Page 537 of the RMC Office for Greenville County. This is the same property conveyed to the Mortgagor by deed of Jeanne D. Threatt dated May 19th, 1978 and recorded on even date herewith.



Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
