with interest thereon from maturity at eight per centum per annum, said principal and interest to be repaid: within 90 days from date

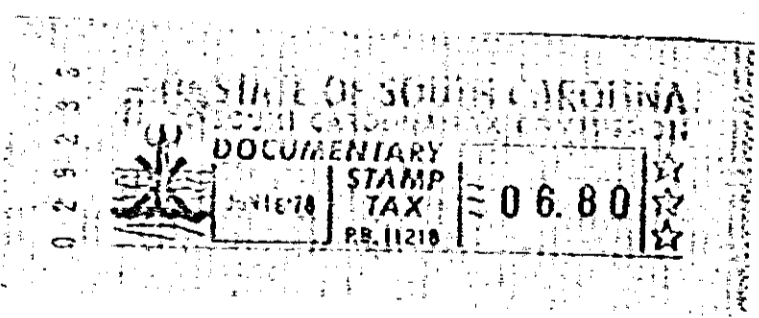
