TO ALL WHOM THESE PRESENTS MAY CONCERN: EDWIN E. CLEMENT and JEAN P. CLEMENT

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of TWENTY FIVE THOUSAND, NINE HUNDRED AND TWO AND 87/100----- DOLLARS

(\$ 25,902.87), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 18 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

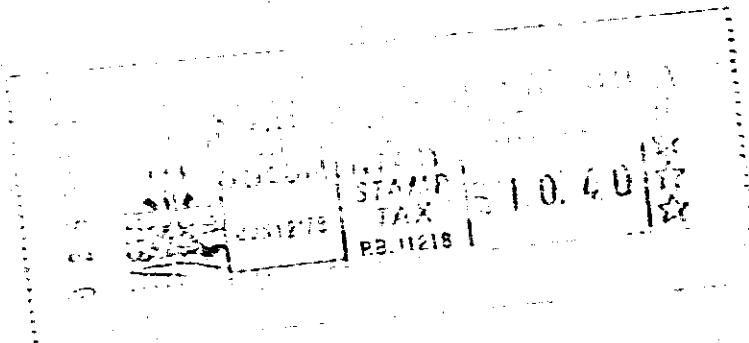
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Grove Township, being shown as Lot No. 3, Section 2, of BELLE TERRE ACRES, on plat by C. O. Riddle, Surveyor, dated July, 1964, revised October, 1965, containing 1.89 acres, and having the following metes and bounds, to-wit:

BEGINNING at a point in the center of South Carolina Highway 106, which point is 204.8 feet east of the joint corner of Lots Nos. 4 and 5, and thence with the line of Lot No. 4, S. 7-40 W. 384.2 feet to an iron pin; thence S. 85-20 E. 225 feet to an iron pin in the joint rear corner of Lots Nos. 2 and 3; thence with the common line of said lots, N. 4-40 E. 383 feet to a point in the center of said South Carolina Highway 106; thence with the center of said South Carolina Highway 106, the following: N. 85-20 W. 153.5 feet to a point; thence N. 84-34 W. 51.4 feet to the point of beginning.
