MORTGAGE OF REAL ESTATE
TO ALL WHOM THESE PRESENTS MAY CONCERN.

WHEREAS, James F. Eddleman and Nancy R. Eddleman,

(hereinafter referred to as Mortgagor) is well and truly indebted unto Sharonview Federal Credit Union, Charlotte, North Carolina,

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Sixteen Thousand Eight Hundred and 00/100-----
-----Dollars (\$ 16, 800. 00) due and payable
in Six Hundred Twenty-Four (624) weekly installments of Forty-Four and 05/100 (\$44.05) Dollars each until paid in full, the first installment being due on September 28, 1978

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, and being more particularly described as Lot 25, Section C, as shown on a plat entitled "A" Subdivision for Woodside Mills, Greenville, South Carolina" made by Pickell and Pickell, Engineers, Greenville, South Carolina, January 14, 1950, and recorded in the RMC Office for Greenville County in Plat Book W at pages 111-117, inclusive. According to said plat, the within described lot is also known as No. 5, East North Sixth Street (Avenue) and fronts thereon 66 feet.

This being the same property conveyed to the Mortgagors herein by Deed of Charles J. Spillane on July 24, 1974, which Deed was recorded in the RMC Office for Greenville County in Deed Book 1003-560.

2. FOOT
