MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

Ann M. McAlister (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Three thousand, Three hundred, twenty-nine and 40/100----- DOLLARS (\$ 3,329.40), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is five (5) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Buckingham Road, in the City of Greenville, being shown as Lot 213 on a plat of Section B, Gower Estates, as shown on plat recorded in Plat Book XX at Page 37, and described as follows:

BEGINNING at an iron pin on the Southern side of Buckingham Road, at the corner of Lot 214, and running thence with the curve of the Southern side of Buckingham Road and chord of which is S. 68-18 E. 65 feet to an iron pin at the corner of Lot 260; thence with the line of said lot, S. 12-52 W. 205.9 feet to iron pin at the corner of Lot 212; thence N. 21-40 W. 72.4 feet to iron pin at the corner of Lot 215; thence with the line of said lot, N. 39-23 E. 241.8 feet to the beginning corner.
