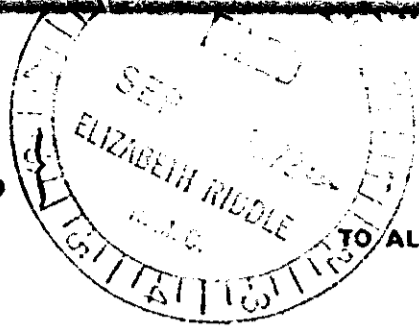

WHEREAS, I, Ruby S. Durham

(hereinafter referred to as Mortgagor) is well and truly indebted unto B. P. Edwards and his heirs and assigns:-

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Three thousand and No/100- - - - - Dollars (\$ 3,000.00) due and payable
\$40.00 per month until principal and interest are paid in full-

with interest thereon from date at the rate of eight per centum per annum, to be paid: annually from date hereof

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Located at Taylors S.C. and being more

particularly described as Lot. No. 61, as shown on a Plat entitled "Section One" Subdivision for Burlington Industries, Inc. Taylors South Carolina, made by Piedmont Engineers and Architects, October, 1964, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book JJJ at Page 10.

According to said Plat, the within described Lot is also known as No. 5, South Street (Avenue) and fronts thereon 82.7 feet.

This conveyance is subject to all restriction, setback lines, roadways, zoning ordinances, easements and rights of way of record, if any, affecting the premises hereinabove described.
