with interest thereon from date at the rate of ---9%--- per centum per annum, to be paid: annually.

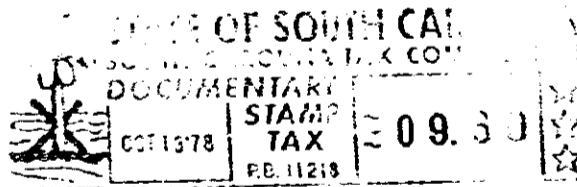

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Mauldin, on East Butler Road, and being shown and designated on the Greenville County Block Book as Sheet M5.1, Block 1, Lot 1, and being the rear portion of Lots 19 and 20 as shown on plat of property of C. A. and Jessie M. Rice prepared by W. J. Riddle, Surveyor, dated June 15, 1939.
