MORTGAGE

THIS MORTGAGE is made this 18th day of December, 1978, between the Mortgagor, Harrison L. Coleman and Clara L. Coleman, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of ONE HUNDRED THIRTY THOUSAND AND 00/100 Dollars, which indebtedness is evidenced by Borrower's note dated December 18, 1978, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on January 1, 2009.....;

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, on the northern side of Edwards Road, near the City of Greenville, being shown and designated as Lot 40-A and part Lot 40 on a survey entitled "Property of Harrison L. Coleman and Clara L. Coleman", prepared by Carolina Surveying Company, dated December 14, 1978 and recorded in the R. M. C. Office for Greenville County in Plat Book 6-Y at Page 13, reference to said plat is hereby craved for a metes and bounds description thereof.
