WHEREAS, Sara S. Purser

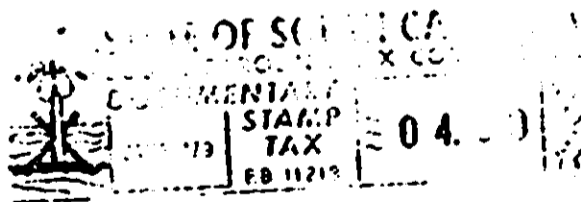
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, the Mortgagee's heirs, successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, being known and designated as Lot No. 178 according to plat of the property of Cleveland Forest made by Dalton & Neves, Engineers, dated May, 1940, revised September, 1945, and recorded in the R.M.C. Office for Greenville, S. C. in Plat Book "M" at Page 137, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Knollwood Lane at the joint front corner of Lots 177 and 178 and running thence along the line of Lot 177, N. 16-30 W. 131.7 feet to an iron pin; thence along the rear line of Lot 182, S. 52-33 W. 60 feet to an iron pin; thence along the line of Lot 179, S. 0-32 E. 102.2 feet to an iron pin; thence along the north side of Knollwood Lane, N. 81-40 E. 85 feet to an iron pin at the point of beginning.

BEING the same property conveyed to the Mortgagor herein by deed of George A. Grady, said deed being dated December 29, 1978 and recorded in the R.M.C. Office for Greenville County in Deed Book 1094 at Page 746.
