"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, in the Town of Mauldin, being shown as an unnumbered lot on a plat of property of J. W. Whitt, prepared by C. O. Riddle, Surveyor, dated August 1968 and also being known as house no. 102 Wilson Street and having, according to said plat, the following metes and bounds, to wit:
