"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of _____

All that piece, parcel or lot of land in Greenville County, State of South Carolina, situate, lying and being on the West side of Townes Street, in Ward one of the City of Greenville and being known as Lot No. 7 on plat known as Townes Street property made by Wm. D.
