WHEREAS, Venna G. Howard

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 52 of a Subdivision known as CANEBRAKE I as shown on plat thereof prepared by Enwright Associates, dated August 18, 1975, revised October 6, 1975, and recorded in the RMC Office for Greenville County in Plat Book 5-D at Page 96 and having such metes and bounds as shown thereon, reference to said plat being made for a more complete description.

THIS is a portion of that same property conveyed to the Mortgagor herein by deed from College Properties, Inc., recorded in the RMC Office for Greenville County on March 30, 1979.
