FIRST PIEDMONT MORTGAGE COMPANY, INC.

(hereinafter referred to as Mortgagor), SENDS GREETINGS:

WHEREAS, the Mortgagor as well and truly indebted unto NORTH CAROLINA NATIONAL BANK, as Agent, (hereinafter referred to as Mortgagee) in the sum of Six Hundred Seventeen Thousand and 00/100 ----- Dollars (\$ 617,000.00) as evidenced by a Revolving Credit Agreement dated December 30, 1974, the terms of which are incorporated herein by reference. All those certain pieces, parcels or tracts of land containing about 42.9 acres situate, lying and being along both Old Mill Road and U. S. Highway 276 in the County of Greenville, State of South Carolina being more particularly described on Exhibit "A" attached hereto and by this reference made a part hereof.

This property is the same property conveyed to Mortgagor by Old Mill Properties by deed dated October 30, 1978 recorded in Deed Book 1093 Page 835.

This mortgage is supplemental to and not in substitution for that certain mortgage on the above described property from Old Mill Properties to Mortgagor recorded in Book 1313 Page 499 assigned to Mortgagee by assignment recorded in Book 1330 at Page 360 and constitutes additional security to Mortgagee for the same indebtedness.
