Amount advanced \$7,231.96.

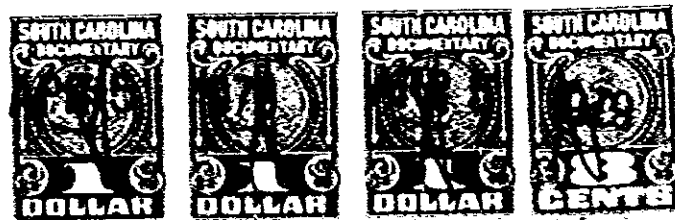
