, a corporation organized and existing under the laws of United States of America, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Thirty-Three Thousand and No/100-----Dollars (\$ 33,000.00), with interest from date at the rate of seven & three-fourths per centum (7-3/4%) per annum until paid, said principal and interest being payable at the office of South Carolina National Bank, Mortgage Loan Department, P. O. Box 168 in Columbia, South Carolina 29202, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Two Hundred Thirty-Six and 61/100-----Dollars (\$ 236.61), commencing on the first day of June, 1979, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of May, 2009.

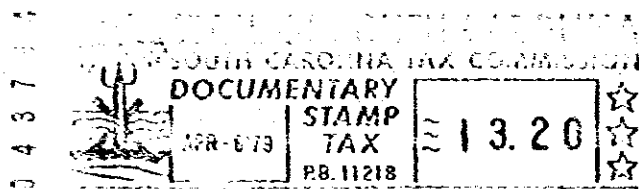
