"All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Bates Township, about one-half mile from the Town of Marietta, containing one-half acre, more or less, being a portion of Lot No. 11 of the property of Central Realty Corp. as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book O, page 39, and having, according to a plat prepared by Harry U. Earle, R. L. S., August 25, 1954, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the line of property belonging to Mae Ellenburg Bates, which pin is situate about 12 feet from the center of the Chestnut Ridge Road, and running thence along the line of other property of the grantor N 81 E 164.9 feet to a new stake; thence continuing along the line of other property belonging to the grantor S 1-30 W 134.4 feet to a new stake on the northern edge of a Duke Power Co. pole line; thence along the northern edge of a Duke Power Co. pole line, S 81 W 164.9 feet to a new stake; thence following the same course 12 feet, more or less, to a point in the center of the Chestnut Ridge Road; thence following the center of said Chestnut Ridge Road in a northerly direction 140 feet, more or less, to a point in the center of said road; thence N 81 E 12 feet, more or less, to the BEGINNING corner."

TO HAVE AND TO HOLD said property unto the Corporation, its successors and assigns, forever, free, clear and discharged of and from any and all liens and claims of the Trustee and the Government and CFC, under and by virtue of any or all of the Security Instruments.

THIS RELEASE is made by the Trustee, made and consented to by the Government and CFC, and accepted by the Corporation on the express condition that it shall not in any way affect or impair the liens or security of the Security Instruments, or any of them, upon other premises and properties now subject thereto and not expressly released hereby. This release is made and accepted without covenant or warranty, express or implied, at law or in equity, and without recourse to the Trustee or the Government and CFC, in any event or in any contingency.

IN WITNESS WHEREOF, The Trustee has executed this instrument and the Government and CFC have caused this instrument to be duly executed in their own behalf and, as holder of all of the Notes, in token of their consent to the execution thereof by the Trustee, all as of the day and year first above written.
