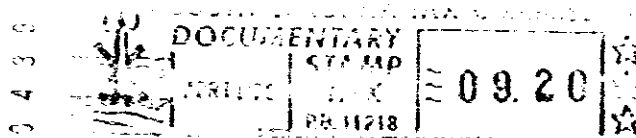

connection with the real estate herein described.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple ab-
