THIS MORTG. GE, made in W.C. on the 9th day of May

(the "Mortgagor") and UNION HOME LOAN CORPORATION OF SOUTH CAROLINA, a body corporate (the "Mortgagee").

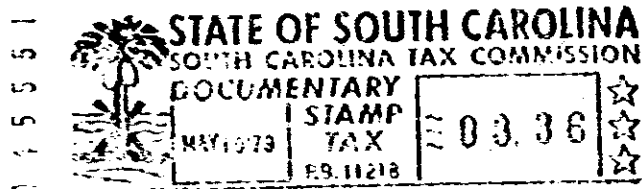
WHEREAS, the Mortgagor is justly indebted unto the Mortgagee in the sum of Twenty thousand eight hundred fifty-two & 50/100ths Dollars (\$ 20,852.50), (the "Mortgage Debt"), for which amount the Mortgagor has signed and delivered a promissory note (the "Note") of even date herewith payable to the Mortgagee, or order, the final installment thereof being due on May 15,, 1989.

KNOW ALL MEN, that the said mortgagor in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said mortgagee, according to the condition of the said note, and also in consideration of the further sum ONE DOLLAR, to the said mortgagor in hand well and truly paid by the said mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presence do grant, bargain, sell and release unto the said mortgagee:

ALL that piece, parcel or lot of land, with all improvements thereon or hereafter constructed thereon, situate, lying and being on the southeastern side of Woodridge Drive in the County of Greenville, State of South Carolina, being shown and designated as Lot No. 48 on Plat of Parkdale, prepared by Dalton & Neves, dated June 1960, recorded in Plat Book RR at Page 55 and being described more particularly, according to said plat, to-wit:

BEGINNING at an iron pin on the southeastern side of of Woodridge Drive at the joint front corner of Lots 47 and 48 and running thence along the common line of said lots S. 50-06 E. 191.3 feet to an iron pin at the joint rear corner of said lots; thence S. 52-00 W. 145 feet to an iron pin at the joint rear corner of Lots 48 and 49; thence along the common line of said lots N. 29-41 W. 187.7 feet to an iron pin on the southeastern side of Woodridge Drive at the joint front corner of said lots; thence along said Drive N. 51-02 E. 77.8 feet to an iron pin, the point of beginning.
