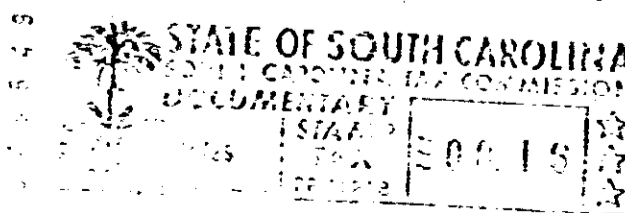
ALL that certain piece, parcel or lot of land in the State of South Carolina, County of Pickens, on the south side of U.S. Highway 123 leading from Easley to Liberty, being in Rolling Wood Estates and shown and identified as Lot Forty-three (43) on plat of survey by Paul Clark, Surveyor, July 25, 1959, recorded in Plat Book 1920, at Page 64, in the Office of the Clerk of Court for Pickens County, South Carolina, being more fully described, to-wit:

BEGINNING at an iron pin on Rolling Wood Drive on line with Lot No. 44 S. 29 E. 200 feet to an iron pin; thence E. 66 W. 155 feet to an iron pin this being back line of Lot No. 43; thence N. 25 W. 200 feet to an iron pin on Rolling Wood Drive; thence N. 66 E. 130 feet along Rolling Wood Drive to Beginning corner.
