THIS MORTGAGE is made this 8th day of June, 1979, between the Mortgagor, Premier Investment Co., Inc. (herein "Borrower"), and the Mortgagee, UNITED FEDERAL SAVINGS AND LOAN ASSOCIATION OF FOUNTAIN INN, a corporation organized and existing under the laws of the United States of America, whose address is 201 Trade Street, Fountain Inn, S. C. 29644 (herein "Lender").

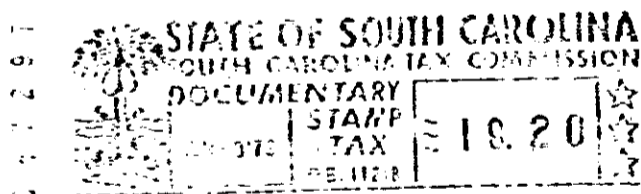
WHEREAS, Borrower is indebted to Lender in the principal sum of Forty Eight Thousand and no/100 Dollars, which indebtedness is evidenced by Borrower's note dated June 8, 1979 (herein "Note"), providing for monthly installments of principal and interest with the balance of the indebtedness, if not sooner paid, due and payable on September 1, 2009;

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of _____, State of South Carolina:

All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 159 on plat of Devenger Place, recorded in Plat Book 7C at page 6 and having the following courses and distances:

BEGINNING at an iron pin on Leeward Terrace, joint front corner of Lots 159 with Bloomfield Lane and running thence along Bloomfield Lane, S. 4-18 E. 125.22 feet to an iron pin; thence along the rear line of Lot 159, N. 85-42 W. 105 feet to an iron pin; thence with the joint line of Lots 159 and 160, N. 4-18 E. 150 feet to an iron pin on Leeward Terrace; thence with said Terrace, S. 85-42 E. 71.8 feet to an iron pin in curve; thence with curve, S. 42-15 E. 36.3 feet to an iron pin, the point of beginning.

Borrower covenants that Borrower is lawfully seized of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
