TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, I, (We) T. Wayne Crolley & Mary H. The said principal and interest shall be payable at the office of THE SOUTH CAROLINA NATIONAL BANK Camden, South Carolina in Camden, South Carolina or at such other place as the holder hereof may designate in writing at the times and in one installments as follows:

Principal and interest due and payable six (6) months from date of this instrument

Handwritten notes and scribbles, including 'for MHC' and 'MHC' repeated multiple times across the document.

All installments of principal and interest are payable in lawful money of the United States of America; and in the event default is made in the payment of any installment or installments, or any part thereof, as therein provided, the same shall bear simple interest from the date of such default until paid at the rate of _____ per centum per annum

And if at any time any installment or portion of principal or interest shall be past due and unpaid, or if default be made in respect to any condition, agreement or covenant contained herein, then the whole sum of the principal of said note remaining at that time unpaid together with the accrued interest, shall become immediately due and payable, at the option of the holder thereof, who may sue thereon and fore close this mortgage; and if said note, after default, should be placed in the hands of an attorney for suit or collection, or if, at any time, it should be deemed by the holder thereof necessary for the protection of its interests to place, and the holder should place, the said note and mortgage in the hands of an attorney for any legal proceedings; then and in either of such cases the mortgagor promises to pay all costs and expenses including a reasonable attorney's fee, these to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt
