with interest thereon from date at the rate of nine (9) per centum per annum, to be paid: Annually

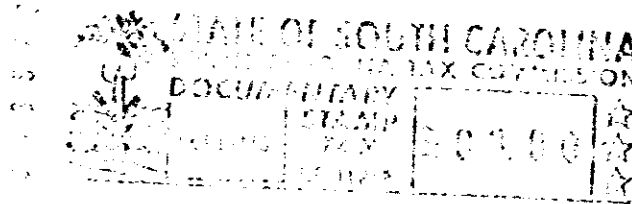
