"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of *Greenville*,

*Greenville Township, being the southwest portion of Lot No. 4 on plat of property of Eliza D. Ware, shown on plat recorded in the RMC Office for Greenville County in Plat Book M at Page 27, and according to a recent survey by T. C. Adams, having the following metes and bounds, to-wit:*

*BEGINNING at an iron pin on the southwest side of Marion Road, the joint corner of Lots 3 and 4, and running thence with line of Lot No. 3, S. 41-15 W. 157 feet to an iron pin, joint corner of Lots 3 and 4 on View Point Drive; thence with View Point, N. 49-0 W. 80 feet to an iron pin; thence in a new line through Lot No. 4 N. 44-0 E. 129 feet to an iron pin on Marion Road; this point being 220 feet to the intersection of View Point Drive and Marion Road; thence with Marion Road, S. 72-0 E. 80 feet to the beginning corner.*
