WHEREAS, I, Fred Barbare

(hereinafter referred to as Mortgagor) is well and truly indebted unto Leon Hix

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of ---Two Thousand Sixty One and 40/100--

Dollars (\$2,061.40) due and payable

in monthly installments of \$85.90 each, first payment due and payable thirty (30) days from date, and to continue on the same date each and every month thereafter for a period of 24 months; entire balance of principal and interest due and payable two years from date,

with interest thereon from date of maturity at the rate of -10- per centum per annum, to be paid: at maturity

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, about two miles northeast from the City of Greer and on the south side of a new street which leads westwardly from the Miller Bridge Road, and being known as all of LOT NO. 34 on plat of property made for B. H. Burnett, by J.Q. Bruce, dated 2-6-50, recorded in Plat Book X page 119, RMC Office for Greenville County, reference to said plat hereby pleaded for a more complete description as to metes and bounds, courses and distances.

This conveyance is subject to all restrictions, easements, rights of way, roadways and zoning ordinances of record, on the recorded plats or on the premises.
