## MORTGAGE

THIS MORTGAGE is made this 1st day of November, 1979, between the Mortgagor, Frank P. Hammond and William F. Case, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Twenty-Nine Thousand Two Hundred and No/100--- Dollars, which indebtedness is evidenced by Borrower's note dated November 1, 1979, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on November 1, 2010.....;

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, Gantt Township, State of South Carolina, being shown and designated as Lot 16 on Pine Ridge Drive on a "Map of Fresh Meadow Farms made for Lehman A. Moseley and C. Henry Branyon" by Madison H. Woodward, R.E., dated May 21, 1945, and recorded in the RMC Office for Greenville County, South Carolina, in Plat Book S at Page 61, reference to said plat being craved for a metes and bounds description thereof.

This is the same property conveyed to the Mortgagors herein by deed of Citizens and Southern National Bank of South Carolina and Lowell H. Tankersley, as Co-Trustees under the Trust created by the Last Will and Testament of Lehman Adwell Moseley, Sr., dated October 25, 1979, recorded in the RMC Office for Greenville County in Deed Book 114 at Page 240.
