# MORTGAGE

THIS MORTGAGE is made this 19th day of November, 1979, between the Mortgagor, Ron F. Levin, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Seventy-Three Thousand Three Hundred Fifty and No/100-- Dollars, which indebtedness is evidenced by Borrower's note dated November 19, 1979, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on December 1, 2009

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

ALL that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, in the City of Mauldin, being known and designated as Lot No. 92 on plat entitled "Property of Ron F. Levin" as recorded in Plat Book 7-5 at Page 20, in the RMC Office for Greenville County, S.C. and having, according to the plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Creekwood Court, said pin being approximately 176 feet from the intersection of Over Creek Rd. and Creekwood Court running thence N. 11-11 E. 197.0 feet to an iron pin; thence S. 78-47 E. 100.0 feet to an iron pin; thence S. 11-13 W. 201.2 feet to an iron pin; thence N. 76-24 W. 100.0 feet to an iron pin, the point of beginning.

Borrower covenants that Borrower is lawfully seized of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
