SEND GREETING:

WHEREAS, I the said Howard W. Redmon

in and by my certain promissory note in writing of even date with these Presents, am well

and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of

Three Thousand Five Hundred & No/100 ----- (\$ 3,500.00) Dollars,

with interest from the date hereof at the rate of Fourteen per cent (14 %) per annum, unpaid interest to

bear interest at the same rate, to be repaid in installments of

Sixty & 81/100 ----- (\$ 60.81) Dollars

C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to me the said mortgagor in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, located in the City of Greer, on the South side of West Poinsett Street and being shown as lot number FIVE (5) or the Baynardlot, which included lots 9 and 14, on plat made for R. J. Ellis et al, by W. A. Christopher, surveyor, dated May 10, 1923, and recorded in plat book Q page 7A, Greenville County R. M. C. Office, and which line have been established by fences on both side of lot in excess of 40 years and having the following courses and distances, to wit:

Beginning on the Southern side of West Poinsett St., at corner of property now of Nell C. Miller, being 93 feet from Beverly Lane, corner of lot No. 5 and small strip shown as lot No. 10 and running thence with the Miller lot, S. 5 W., 192 feet to corner of lot No. 6 and small strip shown as lot No. 14; thence S. 87-25 W., 71 feet to corner of Stanley J. & Hazel M.
