THIS MORTGAGE is made this 11/22 day of November, 1979, between the Mortgagor, John L. Neely and Linda F. 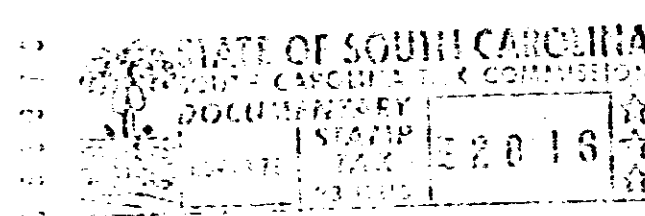
TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

All that piece, parcel and lot of land situate in the County and State aforesaid, in the Gant township described as follows:

Beginning at the joint corners of lots 6 & 7 and Maxwell Avenue, thence S23-55 W 200 feet to a point at the corners of lots 5 and 6 and Maxwell Avenue; thence N66-05 W 157.1 feet to a point; thence N 15-46 E 202 feet to the point corners of lots 6 and 7; thence S66-05 E 185.7 feet to the point of beginning.

This property is subject to the restrictions of record in Volume 813, Page 502, RMC Office of the aforesaid County and State as well as other easements as Right-of-Way of record or apparent upon visual inspection.

This is the same property conveyed to grantor by deed of B. B. Dubose and Sandra W. Dubose recorded July 17, 1979 in Volume 1106, Page 832, RMC Office of Greenville County, and a plat of said property being recorded in Plat Book 000 at Page 37 in said office.
