MODIFICATION & ASSUMPTION AGREEMENT

STATE OF SOUTH CAROLINA

WHEREAS Fidelity Federal Savings and Loan Association of Greenville, South Carolina, hereinafter referred to as the ASSOCIATION, is the owner and holder of a promissory note dated May 2, 1979, executed by Thomas T. Bartosiak in the original sum of \$ 75,750.00 bearing interest at the rate of 10-5/8 % and secured by a first mortgage on the premises being known as Lot 6, Holly Tree Plantation, Phase No. II, Section 2, Greenville County, which is recorded in the RMC office for Greenville County in Mortgage Book 1465, page 715, title to which property is now being transferred to the undersigned OBLIGOR(S), who has (have) agreed to assume said mortgage loan and to pay the balance due thereon; and WHEREAS the ASSOCIATION has agreed to said transfer of ownership of the mortgaged premises to the OBLIGOR and his assumption of the mortgage loan, provided the interest rate on the balance due is increased from 10-5/8 % to a present rate of 11-5/8 %.

NOW, THEREFORE, this agreement made and entered into this 29th day of November 29, 1979, by and between the ASSOCIATION, as mortgagee, and Joseph A. Rutkowski and Brunhilde H. Rutkowski, as assuming OBLIGOR,

WITNESSETH:

In consideration of the premises and the further sum of \$1.00 paid by the ASSOCIATION to the OBLIGOR, receipt of which is hereby acknowledged, the undersigned parties agree as follows:

(1) That the loan balance at the time of this assumption is \$ 75,478.06\*; that the ASSOCIATION is presently increasing the interest rate on the balance to 11-5/8 %. That the OBLIGOR agrees to repay said obligation in monthly installments of \$ 740.80 each with payments to be applied first to interest and then to remaining principal balance due from month to month with the first monthly payment being due January 1, 1980.

(2) Should any installment payment become due for a period in excess of (15) fifteen days, the ASSOCIATION may collect a "LATE CHARGE" not to exceed an amount equal to five per centum (5%) of any such past due installment payment.

(3) That all terms and conditions as set out in the note and mortgage shall continue in full force, except as modified expressly by this Agreement.

(4) That this Agreement shall bind jointly and severally the successors and assigns of the ASSOCIATION and OBLIGOR, his heirs, successors and assigns.

IN WITNESS WHEREOF, the parties hereto have set their hands and seals this 29th day of November, 1979.  
\*Balance to be reduced immediately to \$73,800.00.
