THIS MORTGAGE is made and entered into by Alvin L. Hammett and Patsy M. Hammett

residing in Greenville County, South Carolina, whose post office address is
Route 2, Taylors, South Carolina 29687,
herein called "Borrower," and:

WHEREAS Borrower is indebted to the United States of America, acting through the Farmers Home Administration, United States Department of Agriculture, herein called the "Government," as evidenced by one or more promissory note(s) or assumption agreement(s), herein called "note," which has been executed by Borrower, is payable to the order of the Government, authorizes acceleration of the entire indebtedness at the option of the Government upon any default by Borrower, and is described as follows:

And the note evidences a loan to Borrower, and the Government, at any time, may assign the note and insure the payment thereof pursuant to the Consolidated Farm and Rural Development Act, or Title V of the Housing Act of 1949;

And it is the purpose and intent of this instrument that, among other things, at all times when the note is held by the Government, or in the event the Government should assign this instrument without insurance of the note, this instrument shall secure payment of the note; but when the note is held by an insured holder, this instrument shall not secure payment of the note or attach to the debt evidenced thereby, but as to the note and such debt shall constitute an indemnity mortgage to secure the Government against loss under its insurance contract by reason of any default by Borrower:

NOW, THEREFORE, in consideration of the loan(s) and (a) at all times when the note is held by the Government, or in the event the Government should assign this instrument without insurance of the payment of the note, to secure prompt payment of the note and any renewals and extensions thereof and any agreements contained therein, including any provision for the payment of an insurance or other charge, (b) at all times when the note is held by an insured holder, to secure performance of Borrower's agreement herein to indemnify and save harmless the Government against loss under its insurance contract by reason of any default by Borrower, and (c) in any event and at all times to secure the prompt payment of all advances and expenditures made by the Government, with interest, as hereinafter described, and the performance of every covenant and agreement of Borrower contained herein or in any supplementary agreement, Borrower does hereby grant, bargain, sell, release, and assign unto the Government, with general warranty, the following property situated in the State of South Carolina, County(ies) of Greenville:

✓ ALL that certain, peice, parcel, or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, and being known and designated as Lot 14, Paris View Subdivision, Section 1, according to a plat prepared of said subdivision by J. D. Calmes, RLS, April, 1961, and which said plat is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book VV, at Page 101, and according to said plat having the following courses and distances, to-wit:

BEGINNING at a point on the edge of a county road (S.23-156), joint front corner with Lot 15 and running thence with the common line with said lot, S. 39-22 E. 194.3 feet to an iron pin in the line with Lot 16; thence running with the common line with Lots 16 and 31, S. 50-38 W. 100 feet to an iron pin, joint rear corner with Lots 31, 32 and 13; thence running with the common line with Lot 13, N. 39-22 W. 200 feet to a point on the edge of said county road (S. 23-156); thence running with the edge of said road, N. 50-38 E. 51 feet to a point on the edge of said road; thence continuing with the edge of said road, N. 57-30 E. 49 feet to a point on the edge of said road, the point of Beginning.
