SEND GREETINGS:

Whereas, I, we the said Roger L. Chastain and Sheryl F. Chastain hereinafter called Mortgagor, in and by my, our certain note or obligation bearing even date herewith, stand indebted, firmly held and bound unto the Citizens and Southern National Bank of South Carolina, Simpsonville, S. C., hereinafter called Mortgagee, the sum of \$10,627.80 plus interest as stated in the note or obligation, being due and payable in 48 equal monthly installments commencing on the 31st day of January, 1980, and on the same date of each successive month thereafter.

Said note provides that past due principal and/or interest shall bear interest at the rate of seven (7%) per cent per annum as reference being had to said note will more fully appear; default in any payment of either principal or interest to render the whole debt due at the option of the Mortgagee or holder hereof. All that piece, parcel or lot of land in the County of Greenville, State of South Carolina, Situate, lying and being on the eastern side of Seedleaf Court and being known and designated as Lot No. 631 of WESTWOOD Subdivision, Section 6, plat of which is recorded in the RMC Office for Greenville County in Plat Book 4-X at Page 100 and having such metes and bounds as shown thereon, reference to said plat being made for a more complete description.

This conveyance is subject to all restrictions, setback lines, roadways, zoning ordinances, easements and rights-of-way appearing on the property and/or of record.
