BUT THIS COVENANT IS UPON THIS CONDITION: That if the said Mortgagor shall well and truly pay or Mtg. cause to be paid unto the said Mortgagee, its successors or assigns, the said debts and sums of money aforesaid, with Book interest thereon if any shall be due, according to the true intent and meaning of this instrument and of said note and 1752 at the conditions therein written, then this deed of bargain and sale shall cease and be void; otherwise, it shall remain in pg. 596 full force and authority.

And it is also covenanted and agreed that upon default in the payment of said promissory note above described, or on our failure to pay the said taxes, assessments for street or other improvements, and insurance as agreed, or on failure of the Mortgagor to keep and perform any of the covenants or conditions herein, then, or in any one of these events, the whole amount of the indebtedness hereby secured, at that time unpaid shall, at the option of the lawful owner and holder of said note and of this security be and become due and collectible at once, anything hereinbefore or in said note contained to the contrary notwithstanding; such option to be exercised without notice.

And it is further covenanted and agreed that in case any installment is not paid when due or within ten days there- after, the further sum of five per centum on the installment then due shall be paid by the Mortgagor or the person or persons claiming through or under the Mortgagee, as a delinquency charge.

And it is covenanted and agreed that the said mortgagor does hereby assign, set over and transfer to the said Mortga- gee, its successors or assigns, all of the rents, issues and profits of the said mortgaged premises accruing and falling due from and after the service of summons issued in an action to foreclose this mortgage after default in the conditions thereof. And it is further agreed that in the case of foreclosure of this mortgage, by suit or otherwise, the Mortgagee shall recover of the Mortgagor the expense of advertising, selling and conveying, including reasonable attorney's fees not to exceed 15% of the unpaid balance of the indebtedness upon default and other reasonable costs of foreclosure, which shall be secured by this mortgage, and shall be included in judgment of foreclosure. Further, Mortgagor agrees to pay Mortgagee reasonable attorney's fees in the event Mortgagee becomes involved in any suit, proceeding or claim involv- ing this mortgage or title to the property described herein.

And it is covenanted and agreed that no failure of the Mortgagee or its successors or assigns to exercise any option to declare the maturity of any debt secured by this mortgage, shall be taken or deemed as a waiver of its right to exercise such option, or to declare such forfeiture, either as to any past or present default, and it is further agreed that no terms or conditions contained in this mortgage can be waived, altered or changed except as evidenced in writing and signed by all parties hereto.

All appraisements and homestead laws are hereby expressly waived.
