are due on the 15th day of each month thereafter

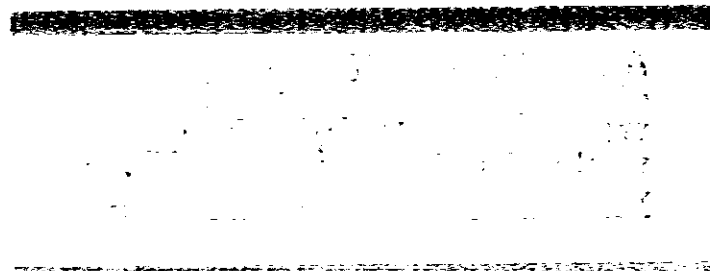
NOW KNOW ALL MEN BY THESE PRESENTS that the said Mortgagor in consideration of the said debts and sums of money aforesaid and for the better securing of the payment thereof, and also to secure the payment of any other sums advanced to said Mortgagor under the terms and provisions of this Mortgage as hereinafter set forth, to the said Mortgagee according to the condition of said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor in hand well and truly paid by the said Mortgagee, at and before the sealing and delivery of these presents, the receipt of which is hereby acknowledged, have granted, bargained, sold and released and by these presents do grant, bargain, sell and release unto the said Mortgagee, its successors and assigns, the following described property:

ALL that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, City of Mauldin, being known and designated as Lot 140 on plat of Forrester Woods, Section II, recorded in the RMC Office for Greenville County, S. C. in Plat Book 4-X, at Page 64, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the eastern side of Crepe Myrtle Court and running thence along the common line of Lots 140 and 141, S. 78-47 E., 150 feet to an iron pin, joint rear corner of Lots 140 and 141; thence with the rear line of Lot 140, S. 11-13 W., 110 feet to an iron pin at the joint rear corner of Lots 140 and 139; thence with the common line of Lots 139 and 140, N. 78-47 W., 150 feet to a point on Crepe Myrtle Court, joint front corner of Lots 139 and 140; thence with Crepe Myrtle Court, N. 11-13 E., 110 feet to the beginning corner.
