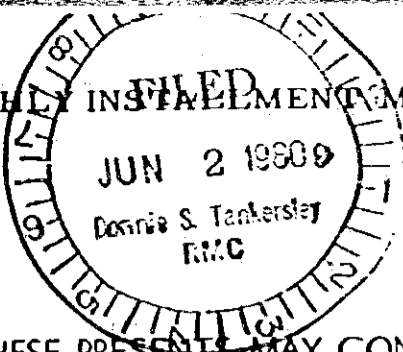

SEND GREETINGS:

Whereas, I, we the said David G. Fisher and Shirley J. Fisher, hereinafter called Mortgagor, in and by my, our certain note or obligation bearing even date herewith, stand indebted, firmly held and bound unto the Citizens and Southern National Bank of South Carolina, Greenville, S. C., hereinafter called Mortgagee, the sum of five thousand seven hundred thirty-six and 32/100 plus interest as stated in the note or obligation, being due and payable in 72 equal monthly installments commencing on the last day of June, 1980, and on the same date of each successive month thereafter.

Said note provides that past due principal and/or interest shall bear interest at the rate of seven (7%) per cent per annum as reference being had to said note will more fully appear; default in any payment of either principal or interest to render the whole debt due at the option of the Mortgagee or holder hereof. Forbearance to exercise this right with respect to any failure or breach of the maker shall not constitute a waiver of the right as to any subsequent failure or breach. at the office of the Mortgagee at Greenville, South Carolina, or at such other place as the holder hereof may from time to time designate in writing

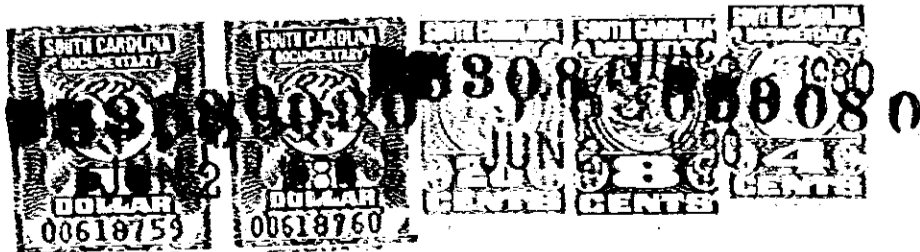

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 63, as shown on a plat of the subdivision of Brookside, Section III, which is recorded in the Office of the R.M.C. for Greenville County, S.C. in plat book 5-N at page 30.

This is a portion of the property conveyed to the grantor by George L. Thompson, et al., by deed dated January 25, 1972 and recorded Jan. 26, 1972 in deed volume 934 at page 565 on the Office of the R.M.C. for Greenville County, South Carolina and is conveyed subject to any restrictions, reservations, zoning ordinances, easements and/or rights of way that may appear of record, on the recorded plat or on the premises.
