Williams, Jr., May 19, 1980, recorded in the RMC Office for Greenville County, S.C., in Plats Book 8-A, at Page 16, and having, according to said latter plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin in Ikes Road on the old property line, which iron pin is 2,900 feet, more or less, west of the intersection of Ikes Road and Brushy Creek Road, and running thence along the line of other property of Fellowship Baptist Church S. 11-05 E. 200 feet to an iron pin; thence S. 78-59 W. 150 feet to an iron pin in the line of property of L.W. Howell; thence along the Howell line N. 11-05 W. 200 feet to an iron pin in Ikes Road on the old property line; thence down Ikes Road N. 78-59 E. 150 feet to an iron pin, the point of beginning.

In all other respects, the lien of said mortgage is unchanged and remains in full force and effect.
