"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville on the West side of Mallard Street beginning at an iron fence post of the West side of Mallard Street being one hundred fifty feet from the intersection of Arlington Avenue and Mallard Street and two hundred fifty three feet from the intersection of Pendleton Street and Mallard Street; thence with the Carter line being the South rear line of a lot conveyed by Equitable Life; thence N. 72-06 W. one hundred feet to a pin; thence N. 18-50 E.
