Now, **KNOW ALL MEN**, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of **Three Dollars (\$3)** to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of **Greenville** State of **South Carolina**;

ALL that certain piece, parcel or lot of land, situate, lying and being in the Town of Simpsonville, Austin Township, on the north side of **Yellow Wood Drive**, being shown and designated as **Lot No. 731, Section VI, Sheet 2 of 2 of WESTWOOD Subdivision**, as shown on plat thereof recorded in Plat Book 5-P at page 35, in the RMC Office for Greenville County, S.C. and also as shown on a more recent plat entitled "**Property of Robert E. Allen and Sandra H. Allen**", prepared by **R. B.
