THIS MORTGAGE is made this 29 day of August
19 80, between the Mortgagor, R. B. Landers

"NOTE" includes all Renewals and Amendments of the Note dated August 29, 1980

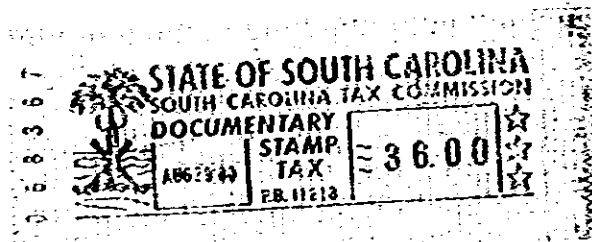
WHEREAS, Borrower is indebted to Lender in the principal sum of Ninety Thousand and no/100 Dollars, which indebtedness is evidenced by Borrower's note dated August 29, 1980 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on February 1, 2011

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

ALL that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown on survey for R. B. Landers and A. Otis DeLaney, recorded in Plat Book 8B, Page 94 and having the following courses and distances:

BEGINNING at an iron pin at the joint front corner of property this date conveyed by Grantor to A. Otis and Sharon D. DeLaney and running thence S. 85-01 W., 226.57 feet to an iron pin; thence S. 6-55 E., 170 feet to an iron pin; thence N. 67-23-48 E., 313 feet to an iron pin on Mustang Circle; thence with Mustang Circle, N. 50-52 W., 107.92 feet to an iron pin, the point of beginning.
