# MORTGAGE

THIS MORTGAGE is made this 29th day of August, 1980, between the Mortgagor, William E. Fuller III & Carolyn Cody Fuller, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of fifty three thousand & 00/100 (\$53,000.00) Dollars, which indebtedness is evidenced by Borrower's note dated August 29, 1980, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on September 1, 2010.....;

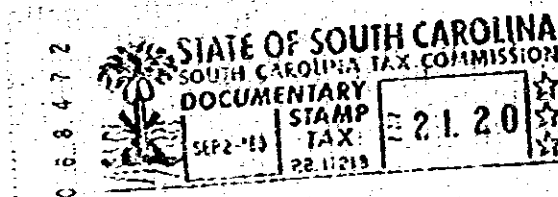

ALL that certain piece, parcel or lot of land, with buildings or improvements thereon, lying and being on the southeasterly side of East Farris Road, in the City of Greenville, South Carolina, being known and designated as lots nos. 17, 18, and a portion of lot no. 19, Block Book F, on a plat of Kanatenah as recorded in the RMC Office for Greenville County, SC in Plat Book F, pages 130 thru 131.
