TO ALL WHOM THESE PRESENTS MAY CONCERN: James R. Johnson and Clara G. Johnson

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Associates Financial Services Co Inc (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Twenty-five Thousand Six Hundred Thirty-two and <sup>no/100</sup> DOLLARS (\$ 25,632.00 ), with interest thereon from date at the rate of 18 per centum per annum, said principal and interest to be repaid: in monthly installments of \$267.00 each, the first of said
