MORTGAGE

THIS MORTGAGE is made this 8th day of OCTOBER, 1980, between the Mortgagor, NANCY L. BALDWIN AND JAMES J. BALDWIN, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").
