"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greer, on the south side of James Street, being known and designated as Lot No. 9, on a plat of property entitled CANNON PARK, Block 1, recorded in Plat Book F, Page 195, being more recently shown on a revised plat of CANNON PARK, Block 1, recorded in Plat Book O. Page 53, and having the following metes and bounds, to-wit:

BEGINNING at the joint front corner of Lot 8 and 9 on Jones Street and running thence along the bank of Jones Street S. 74-35 E. 75 feet, thence along the Snow property (now W. A. Batson) S. 19-14 W. 226 feet to an iron pin, thence along a 15 foot alley N. 76-49 W. 27 feet, thence N. 6-54 E. 224.5 feet to the beginning corner.
