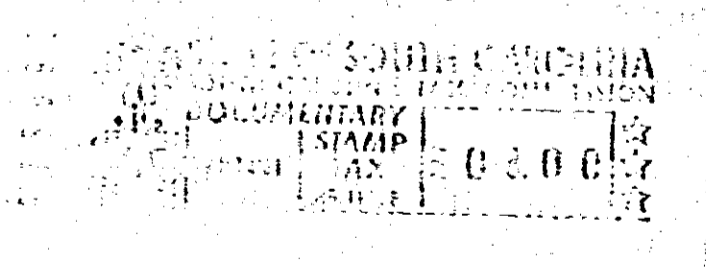
"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

ALL that piece, parcel or lot of land in Bates Township, Greenville County, State of South Carolina, in Travelers Rest, being known and designated as Lot Number 17 on a plat of survey of the subdivision of property of George W. Bridwell, made by T. T. Dill, surveyor, March, 1946, recorded in Plat Book "M" at Page 129 in the R.M.C. Office for Greenville County.

This property has a frontage of 82.4 feet along the southern side of West Road, is bounded on the east by Lot Number 16, on the south side by Lot Number 18 with eastern side line of 150 feet, western side line of 150.5 feet and rear line of 72.3 feet
