MORTGAGE OF REAL ESTATE  
TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, I, M. B. Bowen

(hereinafter referred to as Mortgagor) is well and truly indebted unto Vance E. Edwards

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Three Thousand and No/100

Dollars (\$ 3,000.00 ) due and payable

in monthly installments of Three Hundred and No/100 (\$300.00) Dollars to be applied first to interest, then to principal commencing on the 3rd day of May, 1981 and continuing on the same day thereafter/each month

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

ALL that certain piece, parcel and lot of land, situate, lying and being in Bates Township, Greenville County, South Carolina located within the City of Travelers Rest, South Carolina and located on West Road and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on West Road and running thence with said Road S. 66 3/4 W. 226 feet to an iron pin on Williams Street; thence along said Williams Street S. 22 1/2 E. 192.75 feet to an iron pin; thence N. 66 3/4 E. 226 feet to an iron pin; thence N. 22 1/2 W. 192.75 feet to the point of beginning, and containing one acre, more or less.
